In the spirit of transparency, this Privacy Notice details how Chrysaor processes any personal data collected or received when users visit our website www.chrysaor.com

What Information Does The Company Collect And How Is It Used?

When someone visits www.chrysaor.com we collect standard internet log information and details of visitor behaviour patterns to find out things such as the number of visitors to various parts of the website.

We collect this information in a way which does not identify individuals and we do not make any attempt to find out the identities of those visiting. We will not associate any data gathered from this site with any personally identifying information from any source. If we do want to collect personally identifiable information through our website, we will highlight this in advance. We will make it clear when we collect personal information and will explain what we intend to do with it.

When you submit your personal details to us via our Website Contact Form, we will use that information to respond to your message. Your message will be relayed to the relevant department who will respond directly to you.

We will never share, trade or sell your information to a third party for marketing purposes.

How Do We Use Cookies?

Cookies are small text files placed on your computer by websites you visit. They are widely used in order to make websites work, or work more efficiently, as well as provide information to the owners of the website. Who Has Access To Data?

How Does The Company Protect Data?

Chrysaor has implemented a number of operational controls and internal policies to ensure that your data is not lost, accidentally destroyed, misused or disclosed, and is not accessed except by employees in the performance of their duties.

Should any data be transferred outside of the European Economic Area it will be protected by appropriate transfer safeguards, which guarantee an adequate level of data protection wherever your data is physically kept.

When Chrysaor engages suppliers and partners to process data on our behalf, we do so on the basis of written instructions, ensuring the third party has implemented appropriate technical and organisational measures to ensure the security of data. In certain circumstances, we will ensure that it is protected and transferred in a manner consistent with applicable data protection laws.

Your Rights

As a data subject, you have a number of rights, as follows:

- Access and obtain a copy of your data on request
- To change incorrect or incomplete data
- To delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing
- Object to the processing of your data in certain circumstances
- To stop processing data for a period if data is inaccurate or there is a dispute about whether or not your interests override our legitimate grounds for processing data.
